## Limited Warranty for Stamping Press Repair Service Effective July 2023

#### **Limited Warranty Coverage:**

Columbia Machine Works, Inc. (hereafter referred to as "CMW") provides a limited warranty for its stamping press repair service. This warranty is applicable solely to the specific repair services performed by CMW and is not extended to any purchased items or parts used in the repair process. The original equipment manufacturer (OEM) of those parts is solely responsible for any warranty related to those items.

#### **Warranty Period:**

The limited warranty provided by CMW for stamping press repair services shall be in effect for a period of 30 days from the completion date of the repair.

### **Coverage Limitations:**

The limited warranty covers defects in workmanship and materials related to the specific stamping press repair services performed by CMW.

The warranty does not extend to any parts or components that were not repaired or replaced by CMW during the service process.

Any issues arising from the use of defective or faulty parts provided by the customer or a third party are not covered under this warranty.

The warranty does not apply to damages caused by improper use, neglect, unauthorized modifications, accidents, natural disasters, or other events beyond the control of CMW.

#### **CMW's Discretion:**

CMW reserves the right to inspect the serviced components or products in question to verify the warranty claim and identify the cause of the issue. Based on the inspection, CMW will determine the applicability of the limited warranty. The decision made by CMW will be final and binding.

#### **Warranty Claim Procedure:**

To make a warranty claim, the customer must promptly notify CMW of the issue within the warranty period. The customer shall provide the original job number, a detailed description of the problem, and any relevant supporting documentation.

### **Repair or Replacement:**



Upon receipt of a valid warranty claim, CMW will, at its sole discretion, either repair or replace the defective workmanship or materials covered by this limited warranty. The Company reserves the right to use new, refurbished, or equivalent replacement parts for the repair.

#### **Exclusions:**

CMW shall not be liable for any indirect, incidental, consequential, or special damages arising from the use or inability to use the repaired stamping press, even if the Company has been advised of the possibility of such damages.

### **Transferability:**

This limited warranty is non-transferable and applies only to the original customer who availed of CMW's services.

#### **Acknowledgment:**

By signing this document, you acknowledge CMW's limited warranty for stamping press repair services and agree to the terms and conditions outlined herein.

## **Entire Agreement:**

This limited warranty constitutes the entire agreement between the customer and CMW concerning stamping press repair services and supersedes any prior or contemporaneous understandings, representations, or agreements.

### **Governing Law:**

This limited warranty shall be governed by and construed in accordance with the laws of Tennessee without regard to its conflicts of laws principles.
